Requestor understands there will be a charge for items that are stolen, vandalized, or unrecoverable. Cannot guarantee service on weekends or holidays. After 90 days of sign being up \$10.00 per month will be charge to credit card. Client must sign Installation and Rental Contract. This agreement is between Complete Signs, LLC and (Customer) for the installation and removal of yard signs.

I, the listing agent/company have obtained permission from property owner to install sign post(s) on the property stated (either on the online registration or the registration form) and agree to pay the amount above for service at time of request. In case the owner/tenant of said address refuses installation at time of install, an additional fee of \$25.00 will be assessed.

Fees are determined by the location of the install and our base rate is a 20-mile radius from our office. A fuel surcharge of \$1.00 per mile will be added per order over the 20 mile radius.

Each Install is comprised of One Yard Arm, Brochure Box and Rider. All Yard arms are white unless a different color is specified. The Panel inserts are in addition to the cost, according to size and quantity ordered. Colors are according to logo specification colors, an additional charge of \$5.00 will be added for any additional colors.

The Install fees are all inclusive of the rental fees of said Yard Arm, Brochure Box and Rider are the sole property of Complete Signs, LLC. If the install on said property goes over 90 days there will be an additional \$10.00 fee per month. If said Yard Arm, Brochure Box or Rider is Stolen, Vandalized, and Damaged in any way or not returned, the following fees will apply. Yard Arm - \$75.00, Brochure Box - \$15.00, Rider - \$15.00. Customer will incur a \$20 trip charge for repairs. Elements of weather damage only, will be repaired at no charge for yard arm installations.

Complete Signs, LLC is not responsible for Sprinkler System Damage or any kind of yard lighting damage. Realtor must have owner mark areas where the lines are, or specify the area where the signs should or should not be installed.

All Charges will must be paid by check or cash within 5 business day of install order. Arrangements can be made for billing at the end of the month for Customers that incur significant activity during the month.

Complete Signs, LLC will provide storage for Customers' Sign Inserts and yard arms, at no charge to the customer as long as you are using our services. If we have not had a request for a service in 60 days we will charge a monthly fee for storage. The monthly fee will be in the amount of \$50.00.
